Boarding Agreement

1. Regular Hours for Daycare and Sleepovers are:
Monday - Friday 6:30 AM - 6:30 PM.
Sleepovers Only
Saturday 10:00 AM - 2:00 PM

AGREEMENT

Owner agrees to pay the rate for boarding in effect on the date the pet is checked into the kennel.
Check-in Saturday 10:00 AM - 2:00 PM
(by appointment only)

Late check-out on Saturday after 2:00 PM will be \$1.00/minute
Late check-out on weekdays after 6:30 PM will be \$1.00/minute

2. RESERVATIONS

Owner needs to make Reservation weeks or months in advance for school breaks, holidays, and summer vacations. Cancellations must be made 1 week in advance or a \$20.00 fee will be charged. Owner must provide food for own pet to avoid complications such as allergic reactions your dog may have to certain types of foods. Owner may bring a kennel or crate for their pet or Bow Wow will provide for you. You may also bring treats, chews, or small toys to make your pet feel more at home.

3. Owner further agrees to pay all costs and charges for special services requested, as well as all veterinary cost for the pet during the time said pet is in the care of the boarding facility.
4. By Signing this contract and leaving their pet with kennel, Owner certifies to the accuracy of all information given about said pet in contract.
5. **LIMITATION OF LIABILITY:** Facility shall exercise reasonable care for the pet delivered by the Owner to kennel for boarding. It is expressly agreed by Owner and Kennel that Kennel's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200.00 per animal boarded. Owner assumes all liability for any and all acts, behavior or damages of said pet while it is in the care of the Kennel, including damaged or lost toys, blankets, or other items of personal property that belong to said pet. Owner agrees to defend, indemnify and hold Kennel, its employees and agents, harmless from said acts of behavior of pet.
6. Owner specifically represents that he or she is the sole owner of the pet free and clear of all liens and encumbrances.
7. Owner specifically represents to Kennel that the pet has not been exposed to rabies or distemper within a 30 day period prior to boarding.

8. Owner further agrees that the pet shall not leave the Kennel until all charges are paid to Kennel by Owner. All charges to Owner shall be payable upon pick-up of pet, or when billed by Kennel at address listed on Contract. The Kennel shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding pet at the facility. The Owner hereby agrees that in the event the boarding charges are not paid when due in accordance with this contract, the Boarding facility may exercise its lien rights upon ten days written notice given by Kennel to Owner by certified mail to address shown on Contract. Kennel may dispose of pet for any and all unpaid charges, at private or public sale, in the sole discretion the Kennel, and Owner specifically waves all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs of board or other charges delinquent, plus costs of sale, then Owner shall be liable to Kennel for the difference. All monies realized by Kennel at such sale, over and above the charges due and costs of sale, shall be paid by Kennel to Owner.
9. If pet becomes ill or if the state of the animal's health otherwise requires professional attention, the Kennel, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by the Owner.
10. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives, and assigns of the Owner, and the Boarding Facility.
11. Owner irrevocably agrees that venue for any action or proceeding files under this Contract or to collect any sums owed by Owner to Boarding Facility, shall be in Multnomah County, Oregon. Owner further agrees that if Kennel is compelled to retain an attorney to collect sums owed by Owner to Kennel, Owner agrees to pay all such reasonable attorney's fees, expenses, and court costs, whether or not a lawsuit is filed, including those incurred at trial, on appeal and in preparation therefor.
